This statement is filed with respect to the Ordinary Shares (the "Ordinary Shares") of Wix.com Ltd. (the "Issuer") beneficially owned by the Reporting Persons (as defined below) as of December 31, 2015 and amends and supplements the Schedule 13G filed on December 8, 2014, as previously amended (collectively, the "Schedule 13G"). Except as set forth herein, the Schedule 13G is unmodified.

The names of the persons filing this statement on Schedule 13G (collectively, the "Reporting Persons") are:

- Robert S. Pitts, Jr., a United States Citizen ("Pitts").
- Steadfast Capital Management LP, a Delaware limited partnership (the "Investment Manager").
- Steadfast Advisors LP, a Delaware limited partnership (the "Managing General Partner").
- Steadfast Capital, L.P., a Delaware limited partnership ("Steadfast Capital").
- American Steadfast, L.P., a Delaware limited partnership ("American Steadfast").
- Steadfast International Master Fund Ltd., a Cayman Islands exempted company (the "Offshore Fund").

Mr. Pitts is the controlling principal of the Investment Manager and the Managing General Partner. The Managing General Partner has the power to vote and dispose of the securities held by Steadfast Capital. The Investment Manager has the power to vote and dispose of the securities held by American Steadfast and the Offshore Fund.

(iii) The Managing General Partner's beneficial ownership of 103,760 Ordinary Shares represents less than 1% of the outstanding Ordinary Shares.

(iv) Steadfast Capital's beneficial ownership of 103,760 Ordinary Shares represents less than 1% of the outstanding Ordinary Shares.

(v) American Steadfast's beneficial ownership of 928,730 Ordinary Shares represents 2.4% of the outstanding Ordinary Shares.

(vi) The Offshore Fund's beneficial ownership of 1,543,436 Ordinary Shares represents 4.0% of the outstanding Ordinary Shares.

(vii) Collectively, the Reporting Persons' beneficial ownership of 2,575,926 Ordinary Shares represents 6.7% of the outstanding Ordinary Shares.
