(1) On February 25, 2014, 2,500 restricted shares of Mr. Boehmer's newly-granted Company stock vested. On March 12, 2014, Mr. Boehmer automatically surrendered 794 of the 2,500 newly-vested shares to the Company to satisfy the tax withholding obligation triggered upon the February 25th vesting. The automatic surrender of newly-vested shares is the Company's default process for paying tax withholding obligations triggered upon the vesting of restricted stock.

(2) On March 4, 2014, 2,500 restricted shares of Mr. Boehmer's newly-granted Company stock vested. On March 12, 2014, Mr. Boehmer automatically surrendered 784 of the 2,500 newly-vested shares to the Company to satisfy the tax withholding obligation triggered upon the March 4th vesting.
