(SSFQP), Special Situations Cayman Fund, L.P. (Cayman), Special Situations Private Equity Fund, L.P. (PE) and Special Situations Life Sciences Fund, L.P. (LS). 6,850,445 shares of Common Stock are held by SSFQP, 2,193,746 shares of Common Stock are held by Cayman, 1,632,397 shares of Common Stock are held by PE and 1,249,662 shares of Common Stock are held by LS. The interest of Marx and Greenhouse in the shares of Common Stock owned by SSFQP, Cayman, PE and LS is limited to the extent of his pecuniary interest.
