(SSFQP), Special Situations Cayman Fund, L.P. (Cayman), Special Situations Private Equity Fund, L.P. (PE), Special Situations Technology Fund, L.P. (Tech) and Special Situations Technology Fund II, L.P. (Tech2). 3,158,900 shares of Common Stock are held by SSFQP, 950,000 shares of Common Stock are held by Cayman, 581,385 shares of Common Stock are held by PE, 530,942 shares of Common Stock are held by Tech and 3,290,393 shares of Common Stock are held by Tech2. The interest of Marxe and Greenhouse in the shares of Common Stock owned by SSFQP, Cayman, PE, Tech and Tech2 is limited to the extent of his pecuniary interest.

This is a joint filing by Austin W. Marxe (Marxe) and David M. Greenhouse (Greenhouse). They share voting and investment control over all securities owned by, Special Situations Private Equity Fund, LP (PE), Special Situations Technology Fund, L.P. (Tech) and Special Situations Technology Fund II, L.P. (Tech2). 419,145 Warrants are owned by PE, 231,239 Warrants are owned by Tech and 1,469,616 Warrants are owned by Tech2.
