Item 1.01. Entry into a Material Definitive Agreement

As contemplated by that certain Agreement for Lease dated August 25, 2009, between CoStar UK Limited (“CoStar UK”), a wholly owned U.K. subsidiary of CoStar Group, Inc., and Wells Fargo & Company (“Landlord”), on November 18, 2009, CoStar UK and Landlord entered into a Sub-Underlease (“Lease”) for 10,972 square feet of office space located on the Fifth Floor, 40 Portman Square, London W1.

The Lease has a maximum term ending October 20, 2018, with early termination at CoStar UK’s option on October 18, 2013, with advance notice. The initial base rent is approximately £658,320 per year (excluding VAT, parking, insurance, service charges and property rates), subject to a rent review on October 21, 2013, at which time the rent will be the higher of the then current, open market rental rate and the rent payable immediately prior to the rent review. Rent is payable beginning April 25, 2010.
