- (1) On August 15, 2006, the Charles S. Hale Testamentary Trust ("Trust") contained 424,275 shares of Chemtura Corporation common stock. Effective that date, the Trust was split into two trusts; one for the benefit of Mr. Martin M. Hale and one for the benefit of Mr. Hale's brother. Thus, the Trust for the benefit of Martin M. Hale now holds 212,138 shares of Chemtura Corporation common stock, for which Mr. Hale has sole dispositive power and for which he disclaims beneficial ownership.
