 Mr. Sampson beneficially owns 1,197,436.385 shares of the outstanding common stock of the Issuer, which includes: (i) 1,101,698 shares of common stock owned by Mr. Sampson individually; (ii) options held by Mr. Sampson and exercisable within 60 days of December 31, 2007 to purchase 38,000 shares of common stock; (iii) 40,791.385 shares of the Issuer held by Mr. Sampson through the Communications Systems, Inc. Employee Stock Ownership Plan ( CSI ESOP ); (iv) 16,323 shares owned by Mr. Sampson s spouse; and (v) 624 shares held by the Sampson Family Foundation, a charitable foundation of which Mr. Sampson is the sole trustee. Mr. Sampson also is a trustee of the CSI ESOP. As of December 31, 2007, the CSI ESOP held 549,033 shares of the Issuer. Mr. Sampson disclaims any beneficial ownership of the shares of the Issuer owned by his spouse or the Sampson Family Foundation and disclaims beneficial ownership of any shares of the Issuer held by the CSI ESOP in excess of the shares allocated to his CSI ESOP account, which totaled 40,791.385 shares.

 13.6% based on 8,803,295 shares of the Issuer s common stock outstanding (on average) for the three month period ending September 30, 2007 as reported in the Issuer s Form 10-Q filed November 13, 2007 and including all 1,197,436.385 shares that could be deemed to be beneficially owned by Mr. Sampson. If all shares held by the CSI ESOP allocated to accounts other than that of Mr. Sampson were included in the number of shares beneficially owned by Mr. Sampson, Mr. Sampson would hold 1,705,678 shares of the Issuer, or 19.375% based on 8,803,295 shares of the Issuer s common stock outstanding (on average) for the three month period ending September 30, 2007 as reported in the Issuer s Form 10-Q filed November 13, 2007.
