Portugal Telecom, SGPS S.A. (PT) informs that it was notified by Barclays Plc of the expiration, on 12 October 2011, of an equity swap equal to 4,253,241 shares representing 0.47% of PT share capital and voting rights, which was held by Barclays Capital Securities Ltd. Nonetheless, Barclays Plc's long position in PT remained above the 2% threshold of reportable interests as was previously disclosed.

It was further communicated that Barclays Capital Securities Ltd currently holds the following financial instruments:
