The Registrant was unable to timely file its Annual Report on Form 10-K as a result of financial statement adjustments and disclosures related to the OMONTYS product recall and the recently initiated restructuring efforts described in more detail in its Current Report on Form 8-K filed on March 18, 2013. Based on discussions with its registered independent accounting firm, their audit procedures are still in process, and as a result they are unable to issue the required opinion as of the required filing date.
