Item 5.07. Submission of Matters to a Vote of Security Holders.

The 2015 Annual Meeting of Stockholders (the Annual Meeting) of the Company was held on May 12, 2015. The following is a brief description of each matter voted upon at the Annual Meeting, as well as the number of votes cast for or against each matter and the number of abstentions and broker non-votes with respect to each matter. A more complete description of each matter is set forth in the Company's definitive proxy statement for the Annual Meeting filed with the Securities and Exchange Commission on March 30, 2015.

- Each of the three directors proposed by the Company for re-election was elected by the following votes to serve until the Company's 2018 Annual Meeting of Stockholders or until his respective successor has been elected and qualified. The tabulation of votes on this matter was as follows:

Raul R. Rodriguez	56,483,731	530,600
Gary A. Lyons	45,690,307	11,324,024
Donald G. Payan, M.D.	54,938,962	2,075,369

There were 14,597,879 broker non-votes for this matter.

- The Company's stockholders approved, on an advisory basis, the compensation of the Company's named executive officers.

The tabulation of votes on this matter was as follows: shares voted for: 56,527,155; shares voted against: 254,789; shares abstaining: 232,387; and broker non-votes: 14,597,879.

- The Company's stockholders ratified the selection of Ernst & Young LLP as the independent registered public accounting firm of the Company for its fiscal year ending December 31, 2015.

The tabulation of votes on this matter was as follows: shares voted for: 69,413,363; shares voted against: 2,063,159; and shares abstaining: 135,688.
