- The restricted stock units ("RSUs") were granted pursuant to an amendment to Mr. Hadrill's employment agreement. The amendment to Mr. Hadrill's agreement was entered into, in light of the successful achievement of certain of the Company's integration and synergy-related goals that Mr. Hadrill was supporting, to reflect a shift in Mr. Hadrill's responsibilities to increase his focus on supporting the Company's business development efforts and special strategic projects assigned to him by the Company's CEO and the board of directors.
- (2) 50% of the RSUs are scheduled to vest on December 31, 2016 and 50% of the RSUs are scheduled to vest on December 31, 2017.
