As of December 31, 2015, the Reporting Person owned 15,174,457 shares of Class B common stock and restricted stock units that will convert in 5,000 shares of Class B common stock within 60 days after December 31, 2015. Each share of Class B common stock is convertible at any time at the option of the Reporting Person into one share of Class A Common. In addition, each share of Class B Common Stock will automatically convert into one share of Class A Common Stock (a) upon transfer thereof, subject to certain exceptions, (b) upon the date on which the outstanding shares of Class B Common Stock represent less than 10% of the aggregate number of shares of the then outstanding Class A Common Stock and Class B Common Stock, or (c) in the event that holders of at least 66 $\frac{2}{3}$ % of the then outstanding shares of Class B Common Stock elect to convert all shares of Class B Common Stock into shares of Class A Common Stock.

The ownership percentage above is based on an aggregate of 60,993,694 shares of Class A Common Stock outstanding, consisting of (i) 45,814,237 shares of Class A Common Stock outstanding as of December 31, 2015, and (ii) 15,179,457 shares of Class A Common Stock issuable upon conversion on a one-for-one basis of 15,179,457 shares of Class B common stock owned by the reporting person or issuable to the Reporting Person within 60 days after December 31, 2015.
