Investment description

- Linked to the EURO STOXX 50® Index
- Unlike ordinary debt securities, the securities do not pay interest at a specified rate or repay a fixed amount of principal at maturity. Instead, the securities provide for a Redemption Amount that may be greater than, equal to or less than the Principal Amount of the securities, depending on the performance of the Index from the Starting Level to the Ending Level.
- The Redemption Amount will reflect the following terms:

If the level of the Index increases:

You will receive the Principal Amount plus 300% participation in the upside performance of the Index, subject to a maximum total return at maturity of 27% to 32% (to be determined on the Pricing Date)

If the level of the Index decreases, but the decrease is not by more than 10%, or does not change:

You will be repaid the Principal Amount

If the level of the Index decreases by more than 10%:

You will receive less than the Principal Amount and will have 1-to-1 downside exposure to the decrease in the level of the Index in excess of 10%

- Investors may lose up to 90% of the Principal Amount
