The shares of Common Stock include 22,159 unvested time-based restricted stock awards granted pursuant to the Remington Hotels, LLC
- (2) Ashford Stock Plan of which 12,330 of the shares will vest on March 15, 2019, 6,557 of the shares will vest on March 15, 2020 and 3,272 of the shares will vest on March 15, 2021.
