- (3) Restricted Stock Units granted under the Plan. Subject to terms of the Plan, units vested in four installments on August 20, 2011 (887 units), November 20, 2011 (888 units), February 20, 2012 (888 units) and May 20, 2012 (888 units), with payment of the units deferred until May 21, 2012.
