These common shares were acquired upon the vesting of dividend equivalent units related to the performance-based restricted stock unit (1) award granted in 2012 and deferred by the reporting person. These dividend equivalent units are not eligible for deferral under any applicable plan.

(2) The reporting person elected to defer receipt, upon the vesting thereof, of performance-based restricted shares granted in 2007. This Form 4 reports the disposition of such restricted shares in exchange for an equal number of deferred compensation units under the applicable deferral plan.
