- (1) The restricted stock units were earned based on Company performance during fiscal 2015 and vested in one installment based on continued employment through the end of fiscal 2017.
- (2) Includes 0.0237 shares acquired under a dividend reinvestment plan.
- (3) Shares were withheld to cover tax withholding upon the vesting of the restricted stock units.

- (6) Original option grant vests in three annual installments beginning on the date listed in the "Date Exercisable" column.
