- (1) These shares constitute restricted Common Shares granted pursuant to the M/I Homes, Inc. 1993 Stock Incentive Plan as Amended. To the extent the Company achieves during the 2007 fiscal year certain levels of net income, return on equity and homebuyer satisfaction ratings, a percentage of the restricted Common Shares will vest in thirty-three and one-third percent (33 1/3%) increments on the first three anniversaries of the date of the grant, subject to the reporting person's continued employment with the Company on the applicable anniversary date.
- (2) The Option was granted pursuant to the M/I Homes, Inc. 1993 Stock Incentive Plan as Amended.
- (3) Twenty percent (20%) of grant becomes exercisable on December 31 immediately following the date of grant and each of the first four anniversaries thereof.
- (4) Thirty-three and one-third percent (33 1/3%) of grant become exercisable on December 31 immediately following the date of grant and each of the first two anniversaries thereof.
