- (1) Ms. Mastantuono did not sell any of the 774 reported shares. Rather, this amount represents shares withheld pursuant to the terms of a shareholder-approved stock plan for the payment of withholding taxes due upon the 1/2/10 vesting of 1,667 shares of the 5,000 shares of restricted stock Ms. Mastantuono was granted on 12/10/07. These withheld shares are not sold on the open market and become Revlon, Inc. treasury shares.
- (2) Of the 8,810 shares beneficially owned, (a) 1,667 shares are unvested restricted shares that the reporting person was granted on 12/10/07 which vest on 1/2/11; and (b) 6,250 shares are unvested restricted shares that the reporting person was granted on 12/8/08 which vest in substantially equal installments on 1/10/10, 1/10/11 and 1/10/12.
