- (1) Exercise price and shares have been adjusted to reflect the 2-for-1 stock split that occurred on September 2, 2010.

- (4) This transaction represents the gift of shares of TSC common stock into a trust for the benefit of the reporting person's grandchildren. - (5) This transaction represents the gift of shares of TSC common stock to a grantor retained annuity trust (GRAT) for the benefit of the reporting person's adult children. The reporting person's spouse is the trustee of the GRAT.
