- (1) Grant of restricted Common Stock under the Brookdale Senior Living Inc. Omnibus Stock Incentive Plan. The shares shall vest ratably in four installments on May 20, 2012, May 20, 2013, May 20, 2014 and May 20, 2015.
- (2) Includes an aggregate of 43 shares of Common Stock acquired under the issuer's Associate Stock Purchase Plan since the date of the reporting person's last report.
- (3) Grant of restricted Common Stock under the Brookdale Senior Living Inc. Omnibus Stock Incentive Plan. 75% of the shares shall vest on May 20, 2014 and 25% of the shares shall vest on May 20, 2015, in each case dependent upon the level of achievement of performance goals established for each tranche by the Compensation Committee. Any performance-based shares which do not vest in any tranche will be forfeited.
