("Paramount"), Hollywood Merger Sub, Inc. and Paramount Nevada Gold Corp. ("Merger Agreement") whereby each share of common stock of Paramount was converted into 0.2016 shares of Coeur common stock, resulting in 6,048 shares Coeur common stock. Value reported is based on closing price of Coeur common stock on April 16, 2015.
 - (2) The option exercise price was reduced by \$0.26 as a result of a spin-off of shares of Paramount Gold Nevada Corp. by the issuer.
