- (1) Direct beneficial ownership of non-derivative securities owned by Mr. Yanko total 944 shares of the Registrant's Common Stock (\$0.50 par value).
- (2) Indirect beneficial ownership of non-derivative securities total 30,668 shares of the Registrant's Common Stock (\$0.50 par value) owned by Mr. Yanko's spouse, Donna Gail Yanko. Ms. Yanko is a director and employee of Mexco Energy Corporation.
- (3) Direct beneficial ownership of stock options (right to buy) total 10,000 shares of the Registrant's Common Stock (\$0.50 par value), which can be acquired at \$6.75 per share.
- (4) Indirect beneficial ownership of stock options (right to buy) is 50,000 shares owned by Mr. Yanko's spouse, Donna Gail Yanko. Of these 50,000 shares, 43,750 shares are vested and can be acquired at the following prices: 10,000 shares @ \$7.75 per share, 10,000 shares @ \$7.50 per share, 10,000 shares @ \$5.25 per share, 10,000 shares @ \$6.75 per share and 3,750 shares @ \$6.00 per share.
- (5) The shares vest 1/4 each year from grant date for four consecutive years as follows: 10,000 options @ \$7.75 were granted on 4/2/98 and expire 4/2/08; 10,000 options @ \$7.50 were granted on 3/3/99 and expire 3/3/09; 10,000 options @ \$5.25 were granted on 3/21/00 and expire on 3/21/10; 10,000 options @ \$6.75 were granted on 1/23/01 and expire on 1/23/11; 5,000 options @ \$6.00 were granted on 7/10/03 and expire on 7/10/13; 5,000 options @ \$8.24 on 7/12/06 and expire on 7/12/11.
