(1) On April 27, 2011 the Board of Directors approved and granted a restricted stock award of 24,000 shares of NeoGenomics common stock. The terms of the award call for 2,000 shares to vest on the last day of the next 12 quarters starting on June 30, 2011 as long as Mr. Johnson remains a Director of the Company.

(2) On April 15, 2014 the Board of Directors approved and granted a restricted stock award of 3,000 shares of NeoGenomics common stock. The terms of the award call for 750 shares to vest on the last of the next 4 quarters starting on June 30, 2014 as long as Mr. Johnson remains a Director of the Company.
