**Item 2.02. Results of Operations and Financial Condition.**

On July 26, 2012, Ventas, Inc. (the “Company”) issued a press release announcing its results of operations for the quarter ended June 30, 2012. A copy of the press release is furnished herewith as Exhibit 99.1 and incorporated in this Item 2.02 by reference.

The press release states that the Company’s normalized funds from operations (“FFO”) for the quarter ended June 30, 2012 were \$277.8 million, or \$0.95 per diluted common share, as compared to \$141.5 million, or \$0.80 per diluted common share, for the quarter ended June 30, 2011. FFO, as defined by the National Association of Real Estate Investment Trusts (“NAREIT”), for the quarter ended June 30, 2012 was \$236.0 million, or \$0.81 per diluted common share, as compared to \$100.6 million, or \$0.57 per diluted common share, for the quarter ended June 30, 2011. The Company’s net income attributable to common stockholders for the second quarter of 2012 was \$74.0 million, or \$0.25 per diluted common share (including discontinued operations of \$31.5 million), as compared to \$19.7 million, or \$0.11 per diluted common share (including discontinued operations of \$1.2 million), for the comparable period in 2011.

For the six months ended June 30, 2012, the Company’s normalized FFO was \$541.7 million, or \$1.86 per diluted common share, as compared to \$262.6 million, or \$1.54 per diluted common share, for the six months ended June 30, 2011. NAREIT FFO for the six months ended June 30, 2012 was \$450.8 million, or \$1.55 per diluted common share, as compared to \$201.6 million, or \$1.19 per diluted common share, for the six months ended June 30, 2011. The Company’s net income attributable to common stockholders for the first six months of 2012 was \$164.7 million, or \$0.56 per diluted common share (including discontinued operations of \$74.2 million), as compared to \$68.7 million, or \$0.40 per diluted common share (including discontinued operations of \$2.2 million), for the comparable period in 2011.

The press release also states that the Company currently expects its normalized FFO for the year ending December 31, 2012 to be between \$3.70 and \$3.74 per diluted common share. The Company expects its net income attributable to common stockholders for 2012 to be between \$1.08 and \$1.28 per diluted common share.

These factors include without limitation: (a) the ability and willingness of the Company's tenants, operators, borrowers, managers and other third parties to satisfy their obligations under their respective contractual arrangements with the Company, including, in some cases, their obligations to indemnify, defend and hold harmless the Company from and against various claims, litigation and liabilities; (b) the ability of the Company's tenants, operators, borrowers and managers to maintain the financial strength and liquidity necessary to satisfy their respective obligations and liabilities to third parties, including without limitation obligations under their existing credit facilities and other indebtedness; (c) the Company's success in implementing its business strategy and the Company's ability to identify, underwrite, finance, consummate and integrate diversifying acquisitions and investments, including its recent acquisition of Cogdell Spencer Inc. and investments in different asset types and outside the United States; (d) macroeconomic conditions such as a disruption of or lack of access to the capital markets, changes in the debt rating on U.S. government securities, default or delay in payment by the United States of its obligations, and changes in the federal budget resulting in the reduction or nonpayment of Medicare or Medicaid reimbursement rates; (e) the nature and extent of future competition; (f) the extent of future or pending healthcare reform and regulation, including cost containment measures and changes in reimbursement policies, procedures and rates; (g) increases in the Company's borrowing costs as a result of changes in interest rates and other factors; (h) the ability of the Company's operators and managers, as applicable, to comply with laws, rules and regulations in the operation of the Company's properties, to deliver high quality services, to attract and retain qualified personnel and to attract residents and patients; (i) changes in general economic conditions or economic conditions in the markets in which the Company may, from time to time, compete, and the effect of those changes on the Company's revenues, earnings and funding sources; (j) the Company's ability to pay down, refinance, restructure or extend its indebtedness as it becomes due; (k) the Company's ability and willingness to maintain its qualification as a REIT in light of economic, market, legal, tax and other considerations; (l) final determination of the Company's taxable net income for the year ended December 31, 2011 and for the year ending December 31, 2012; (m) the ability and willingness of the Company's tenants to renew their leases with the Company upon expiration of the leases, the Company's ability to reposition its properties on the same or better terms in the event of nonrenewal or in the event the Company exercises its right to replace an existing tenant, and obligations, including indemnification obligations, the Company may incur in connection with the replacement of an existing tenant; (n) risks associated with the Company's senior living operating portfolio, such as factors that can cause volatility in the Company's operating income and earnings generated by those properties, including without limitation national and regional economic conditions, costs of food, materials, energy, labor and services, employee benefit costs, insurance costs and professional and general liability claims, and the timely delivery of accurate property-level financial results for those properties; (o) changes in U.S. and Canadian currency exchange rates; (p) year-over-year changes in the Consumer Price Index and the effect of those changes on the rent escalators contained in the Company's leases, including the rent escalator for Master Lease 2 with Kindred Healthcare, Inc., and the Company's earnings;
