**ITEM 1.01 ENTRY INTO A MATERIAL DEFINITIVE AGREEMENT.**

*Amendment to Credit Facility with Guggenheim Corporate Funding LLC*

On July 5, 2006, Tarrant Apparel Group entered into a Consent and Amendment No. 1 to Credit Agreement with Guggenheim Corporate Funding LLC, as administrative agent and collateral agent for the lenders under our previously disclosed \$65 million credit facility. Pursuant to the amendment, the terms upon which we may borrow \$7 million of the total \$65 million term loan facility were revised. This term loan of \$7

million will be made available for us to borrow at any time within 180 days of the date of the Credit Agreement upon compliance with the borrowing procedures under the credit facility. Under the original credit agreement, we could borrow this \$7 million only for repayment of our convertible debentures.
