Item 8.01. Other Events.

On August 19, 2014, Consolidated Communications Holdings, Inc. (the “Company”) announced that its Board of Directors has set the record date for a special meeting of its stockholders to consider and vote on the proposal to approve the issuance of the Company’s common stock to shareholders of Eventis Corporation, a Minnesota corporation (“Eventis”), in the merger contemplated by the previously announced Agreement and Plan of Merger, dated as of June 29, 2014, by and among the Company, Sky Merger Sub Inc., a newly formed Minnesota corporation and wholly-owned subsidiary of the Company, and Eventis (the “Merger Agreement”) and the proposal to approve the adjournment or postponement of the special meeting, if necessary or appropriate, for among other reasons, the solicitation of additional proxies in the event that there are not sufficient votes at the time of the special meeting to approve the issuance of the Company’s common stock to Eventis shareholders in the merger contemplated by the Merger Agreement. Stockholders of record as of the close of business on August 21, 2014, the record date for the special meeting, will be entitled to notice of and to vote at the special meeting.

The press release announcing the setting of the record date for the special meeting is attached as Exhibit 99.1 to this Current Report on Form 8-K and is incorporated herein by reference.
