(1) The reported transactions involved an amendment of an outstanding option, which may be deemed to be a cancellation of the "old" option and the granting of a replacement option for purposes of Section 16 of the Securities Exchange Act of 1934. The option was originally granted on August 30, 2005 and provides for vesting in equal monthly installments over a period of four years beginning on September 1, 2005.

(2) The options vest over a period of four years, with 25% vesting on the first anniversary of the date of grant and the remainder vesting in equal quarterly installments thereafter.
