The number of shares issued was determined by the Organization and Compensation Committee of Aon's Board of Directors on February 20, 2009 based upon Aon's performance relative to a cumulative adjusted three year earnings per share target for the period beginning January 1, 2006 and ending December 31, 2008. The terms of LPP1 are more fully described in a Form 8-K filed with the SEC on March 22, 2006, and in the plan document filed as Exhibit 10.1 to Aon's Quarterly Report on Form 10-Q for the quarter ended March 31, 2008 filed with the SEC on May 9, 2008.
