(1) 6,423 shares were issued in settlement of the stock units originally granted to the reporting person on June 30, 2010. Each stock unit represented the right to receive one share of The Gap, Inc. common stock.

(2) 341 shares were issued in settlement of dividend equivalent rights on the above-referenced stock units originally granted to the reporting person on June 30, 2010. Each equivalent right was the economic equivalent of one share of The Gap, Inc. common stock.

(3) The reporting person is a general partner of Fisher Core Holdings L.P., a Delaware limited partnership ("Fisher Holdings"), that owns the reported securities. As a general partner of Fisher Holdings, the reporting person may be deemed to have indirect beneficial ownership of all shares of Common Stock of which Fisher Holdings has beneficial ownership. However, the reporting person disclaims beneficial ownership of all shares of Common Stock held by Fisher Holdings except to the extent of his pecuniary interest therein.
