- (1) Each restricted stock unit represents a contingent right to receive one share of HP common stock.
- (2) As previously reported, on 01/15/09 the reporting person was granted 72,740 restricted stock units ("RSUs"), 36,370 of which vested on 01/15/10, and 36,370 of which will vest on 01/15/11. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The number of derivative securities beneficially owned in column 9 includes 54.5994 dividend equivalent rights at \$53.29 per RSU credited to the reporting person's account on 04/07/10.
- (3) As previously reported, on 12/10/09 the Reporting Person was granted 63,415 restricted stock units ("RSUs"), 31,707 of which will vest on 12/10/10 and 31,708 which will vest on 12/10/11. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The number of derivative securities beneficially owned in column 9 includes 95.1998 dividend equivalent rights at \$53.29 per RSU credited to the reporting person's account on 04/07/10.
