(1) Each restricted stock unit represents a contingent right to receive one share of HP common stock.

(2) As previously reported, on 01/15/09 the reporting person was granted 16,410 restricted stock units ("RSUs"), 8,205 of which vested on 01/15/10, and 8,205 of which will vest on 01/15/11. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The number of derivative securities beneficially owned in column 9 includes 12.3175 dividend equivalent rights at \$53.29 per RSU credited to the reporting person's account on 04/07/10.
