(1) Each restricted stock unit represents a contingent right to receive one share of HP common stock.

As previously reported, on 07/17/13 the reporting person was granted 4,174 restricted stock units ("RSUs"), all of which cliff vested on 07/15/14. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The

(2) number of derivative securities beneficially owned immediately prior to the transaction being reported includes 18.0323 dividend equivalent rights at \$33.61 per RSU credited to the reporting person's account on 04/02/14, and 19.7119 dividend equivalent rights at \$33.88 per RSU credited to the reporting person's account on 07/02/14. These RSUs cliff vested on 07/15/14, at which time the vested shares were delivered to the reporting person. The number of derivative securities in column 5 includes 88 vested dividend equivalent rights and a de minimus adjustment of 0.0238 due to fractional rounding of the dividend equivalent rights.

(3) As previously reported, on 04/21/14 the reporting person was granted 5,480 RSUs, all of which will cliff vest on 04/21/15. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The 25.8796 dividend equivalent rights being reported reflect 25.8796 dividend equivalent rights at \$33.88 per RSU credited to the reporting person's account on 07/02/14.
