(1) The stock is restricted stock issued pursuant to the Company's 2001 Stock Incentive Plan. If and when the Company's common stock ("Common Stock") closes at or above per share target prices of \$18.63, \$21.42 or \$24.64 for twenty consecutive trading days, 33% of the restricted stock performance vests (i.e., the transfer and forfeiture restrictions terminate) upon reaching each such price target. In addition, any remaining unvested restricted stock vests on the fourth anniversary of the grant date (February 24, 2008) if the Common Stock closes at or above \$19.44 per share for twenty consecutive days at any time during such four year period. Any shares of restricted stock that have not otherwise vested as set forth in the preceding two sentences will be forfeited on February 24, 2008.
