## Explanation of Responses:

- (1) The entities acquiring these shares are SPO Partners II, L.P. ("SPO Partners"), which bought 277,100 shares, San Francisco Partners II, L.P. ("SF Partners"), which bought 15,300 shares, Phoebe Snow Foundation ("PSF"), which bought 7,300 shares and The Elizabeth R. & William J. Patterson Foundation ("WJPFND"), which bought 300 shares.
- As a result of the purchases causing this filing, 9,773,069 shares of the issuer's common stock are owned directly by SPO Partners, and may be deemed to be indirectly beneficially owned by (i) SPO Advisory Partners, L.P ("SPO Advisory"), the sole general partner of SPO Partners, (ii) SPO Advisory Corp. ("SPO Corp."), the sole general partner of SPO Advisory, and (iii) John H. Scully ("JHS"), William E. Oberndorf ("WEO") and William J. Patterson ("WJP"), the three controlling persons of SPO Corp. Additionally, 484,930 shares of the issuer's common stock are owned directly by SF Partners, and may be deemed to be indirectly beneficially owned by (i) SF Advisory Partners, L.P. ("SF Advisory"), the sole general partner of SF Partners, (ii) SPO Corp., the sole general partner of SF Advisory, and (iii) JHS, WEO & WJP, the three controlling persons of SPO Corp.
- (2) Additionally, as a result of the purchases causing this filing, 229,800 shares of the issuer's common stock are owned directly by PSF.
- (3) Additionally, JHS owns 3,100 shares in his IRAs, which are self-directed. Additionally, 10,000 shares are owned by WJPFND. Additionally, WJP owns 300 shares in his IRA, which is self-directed.
