(1) On October 26, 2004, Mr. Alter was granted an aggregate amount of 210,526 restricted stock units, subject to the satisfaction of vesting requirements over a five-year period, with the first annual vesting on October 26, 2005. Upon vesting, Sunstone Hotel Investors, Inc. will deliver one share of Common Stock for each vested restricted stock unit. Mr. Alter has only the rights of an unsecured creditor in the restricted stock units and no rights as a stockholder in Sunstone Hotel Investors, Inc. until the restricted stock unit vests.

(2) On October 26, 2009, 42,106 restricted stock units vested and 10,842 shares of Common Stock were withheld to satisfy tax withholding obligations. The closing stock price on October 26, 2009 of Sunstone Hotel Investors, Inc. common stock on the New York Stock Exchange was \$8.16.
