(1) On February 16, 2010, NetLogic Microsystems Inc. declared a stock dividend, payable to all holders of record of common stock on March 5, 2010, of one share of common stock for each share of common stock outstanding. As a result, and pursuant to anti-dilution provisions of NetLogic Microsystems' equity incentive plans, this option which was previously reported as an option for 10,000 shares of common stock at an exercise price of \$18.72 per share, was adjusted to 20,000 shares of common stock at an exercise price of \$9.36 per share.

(2) On February 16, 2010, NetLogic Microsystems Inc. declared a stock dividend, payable to all holders of record of common stock on March 5, 2010, of one share of common stock for each share of common stock outstanding. As a result, and pursuant to anti-dilution provisions of NetLogic Microsystems' equity incentive plans, this option which was previously reported as an option for 10,000 shares of common stock at an exercise price of \$26.28 per share, was adjusted to 20,000 shares of common stock at an exercise price of \$13.14 per share.
