Item 5.02. Departure of Directors or Certain Officers; Election of Directors; Appointment of Certain Officers; Compensatory Arrangements of Certain Officers

On February 8, 2012, the Compensation Committee approved the Market Leader, Inc. 2012 Executive Variable Compensation Plan (the "Plan"), which provides for annual incentive payments to executive officers upon achievement of specified quarterly performance goals. Incentive compensation is based on a percentage of base salary for each executive officer ranging from 45% to 100% depending on level of achievement. The Compensation Committee will assess achievement of the stated goals, determine and approve incentive payments for each executive officer and may modify incentive payment amounts or award vehicles and differentiate between executives in their discretion. Executives will not receive a bonus under the Plan if minimum performance targets are not met.
