- (1) As provided in the Issuer's Amended and Restated Certificate of Incorporation, each share of Class B Common Stock is convertible at any time, at the option of the holder, into one share of Class A Common Stock. In addition, each share of Class B Common Stock will convert automatically into one share of Class A Common Stock upon any transfer, whether or not for value, except for certain permitted transfers described in the Issuer's Amended and Restated Certificate of Incorporation.
- (2) The Reporting Person is a newly formed limited partnership formed for the purpose of receiving shares of Class B Common Stock from Revocable KMP Trust. On July 27, 2012, Revocable KMP Trust contributed its 559,673 shares of Class B Common Stock to the Reporting Person, whose general partner is Julytoon Investments GP LLC. Snicky Trust is the sole member of Julytoon Investments GP LLC, the general partner of the Reporting Person.
- (3) No consideration was paid in connection the contribution, which constitutes a "permitted transfer" as defined in the Issuer's Amended and Restated Certificate of Incorporation. The Reporting Person has executed a joinder to and become subject to the provisions of the Amended and Restated Global Hyatt Agreement. Accordingly, immediately following such contribution, the shares remained shares of Class B Common Stock.
