 - (1) As provided in the Issuer's Amended and Restated Certificate of Incorporation, each share of Class B Common Stock is convertible at any time, at the option of the holder, into one share of Class A Common Stock. In addition, each share of Class B Common Stock will convert automatically into one share of Class A Common Stock upon any transfer, whether or not for value, except for certain permitted transfers described in the Issuer's Amended and Restated Certificate of Incorporation.
 - (2) The Reporting Person is a newly formed limited liability company formed for the purpose of being the general partner of Texas 8-26-22 H Company LP and Featherman H Company LP, which are newly formed limited partnerships formed for the purpose of receiving shares of Class B Common Stock from Texas 8-26-22 Trust 2 and The Featherman Trust, respectively.
 - (3) On July 27, 2012, Texas 8-26-22 Trust 2 contributed its 1,879,132 shares of Class B Common Stock to Texas 8-26-22 H Company LP, whose general partner is the Reporting Person, and The Featherman Trust contributed its 4,061,719 shares of Class B Common Stock to Featherman H Company LP, whose general partner is the Reporting Person.
 - (4) No consideration was paid in connection the contribution, which constitutes a "permitted transfer" as defined in the Issuer's Amended and Restated Certificate of Incorporation. The Reporting Person has executed a joinder to and become subject to the provisions of the Amended and Restated Global Hyatt Agreement. Accordingly, immediately following such contribution, the shares remained shares of Class B Common Stock.
