- (1) In lieu of receiving cash fees, the reporting person received 429 stock units, which immediately vested, in the EnerSys Voluntary Deferred Compensation Plan for Non-Employee Directors (the "Plan").  
This amount reflects a matching stock unit contribution by EnerSys for the reporting person's account in the Plan. The matching stock unit contribution vests 25% on each of April 7, 2013, July 7, 2013, October 7, 2013, and January 7, 2014. Such vesting is subject to acceleration or cancellation upon the occurrence of certain events.
- (3) As a result of these transactions, the reporting person has an additional 515 stock units in the Plan. Each of these stock units represents a right to receive one share of EnerSys common stock and is payable upon the reporting person's Termination, as defined in the Plan.
