- (3) Each restricted stock unit represents a contingent right to receive one share of HomeAway common stock.
- (4) On March 27, 2012, the reporting person was granted 12,231 restricted stock units. 6.25% of the restricted stock units vest at the end of each quarter over a period of four years, measured from June 1, 2012, subject to continued service through each vesting date.
