Upon the occurrence of certain events, LTIP Units and OP Units are redeemable, without consideration, by the holder for an equivalent number of shares of Issuer's common stock or for the cash value of such shares, at Issuer's election.
- (2) LTIP Units vested one-half on December 16, 2013, with the remainder vesting one-third in equal installments on December 31 of 2014, 2015 and 2016.
