The sales were effected pursuant to a Rule 10b5-1 trading plan. 117,000 shares were sold on the TSX and 399 shares were sold on AMEX. The sales took place within 6 months of the acquisition by the reporting person of 2,400,000 units, each consisting of one share and one-half warrant of the issuer, on July 24, 2008, at a price of \$0.49 per unit. No short-swing swing profits were realized in respect of these sales under section 16(b) of the Exchange Act, based on the market price of Apollo Gold stock on July 24, 2008 of \$0.40 per share (as required under Exchange Act Rule 16b-6).
