Smith & Nephew plc - Transaction in Own Shares

Smith & Nephew plc announces that on 01 November 2011 it transferred a total of 311,336 ordinary shares of US\$0.20 each to participants of the Smith & Nephew ShareSave Plan and the Smith & Nephew International ShareSave Plan, who had exercised options on that date.
