- (1) Settlement of performance awards granted under Delta's 2010 long-term incentive program which were earned effective February 2, 2012. The grant of the performance awards was approved by the Personnel & Compensation Committee of Delta's Board of Directors (the "Committee") and is exempt from Section 16(b) of the Securities Exchange Act of 1934 under Rule 16b-3(d).
- (2) Shares withheld for payment of tax liability upon settlement of the performance awards earned under Delta's 2010 long-term incentive program. This withholding was approved by the Committee and is exempt from Section 16(b) of the Securities Exchange Act of 1934 under Rules 16b-3(d)(1) and 16b-3(e).
- (3) The Committee granted Mr. Gorman 114,870 shares of restricted common stock under Delta's 2012 long-term incentive program. Subject to the terms of the award, including Mr. Gorman's continued employment with Delta, the restrictions on the shares will lapse with respect to 50 percent of the shares on each of February 1, 2013 and February 1, 2014. Until the restrictions lapse, Mr. Gorman may not sell or

transfer the shares, which will be subject to forfeiture in certain circumstances

- (4) The shares represent a restricted stock award to Mr. Gorman, as approved by the Committee on February 2, 2012. Subject to the terms of the award, including Mr. Gorman's continued employment with Delta, the restrictions will lapse with respect to 50 percent of the shares on each of February 1, 2014 and February 1, 2015. Until the restrictions lapse, Mr. Gorman may not sell or transfer the shares, which will be subject to forfeiture in certain circumstances.
