**Item 2.06. Material Impairments.**

As described under Item 8.01, Captaris, Inc. (the Company) announced corporate changes intended to improve the efficiency and cost structure of the business. As a result of these changes, on November 3, 2005, the officers of the Company determined that the Company will record a non-cash impairment charge in the fourth quarter of 2005 of approximately \$440,000 for the write-off of an application systems software project that will not be pursued by the Company. The Company does not anticipate future cash expenditures in connection with this write-off.

**Item 8.01. Other Events.**

On November 3, 2005, the Company announced corporate changes intended to improve the efficiency and cost structure of the business. These changes include a reduction in its workforce, the consolidation of office facilities, and as described above in Item 2.06, a write-off of amounts previously deferred for an application systems software project. The workforce reduction includes certain founders of Teemplate, which the Company acquired in September 2003, and triggers the acceleration of the remaining Teemplate management incentive plan obligation associated with the acquisition. The Company expects to record a charge of approximately \$2.3 million in the fourth quarter of 2005, of which approximately \$2.0 million are cash expenditures in that quarter. The charge is comprised of approximately \$620,000 of severance and related costs for the workforce reduction, \$1.0 million for the Teemplate incentive plan obligation, approximately \$193,000 for the consolidation of office facilities, and approximately \$440,000 for the write-off of the application systems software project.
