BHP BILLITON OFFER FOR RIO TINTO LAPSES

BHP Billiton notes the statement made by the UK Takeover Panel Executive agreeing that pre-condition (A) to BHP Billiton s offer for Rio Tinto plc cannot now be satisfied and that, as a result, the UK offer period with respect to Rio Tinto and BHP Billiton ceased with immediate effect. Accordingly, BHP Billiton notes that its offer for Rio Tinto plc has now lapsed and that, given the inter-conditionality of its offers for Rio Tinto plc and Rio Tinto Limited, its offer for Rio Tinto Limited has also now lapsed.

BHP Billiton therefore also announces that it is withdrawing its official competition filing (Form CO) from the European Commission and will withdraw its Registration Statement on Form F-4 from the United States Securities and Exchange Commission.
