**Press Release of Joint Venture Investment, ADA Carbon Solutions, LLC.**

In a press release dated December 9, 2009, ADA Carbon Solutions, LLC ( Carbon Solutions ), a joint venture investment of ADA-ES, Inc., announced that the U.S. Department of Energy's Credit Review Board issued a conditional commitment to Red River Environmental Products, LLC ( Red River ), a wholly-owned subsidiary of Carbon Solutions, for a \$245 million guaranty of debt financing for Red River's activated carbon facility.
