Geo. Garvin Brown IV and Campbell P. Brown have agreed in principle to act together for the purpose of holding and voting certain equity securities of the issuer, through the formation of CBGB LLC, a Delaware limited liability company. Each reporting person may be deemed to have acquired beneficial ownership of the equity securities of the issuer beneficially owned by the other reporting person. As of December 31, 2011, the aggregate beneficial ownership of the Geo. Garvin Brown IV and Campbell P. Brown group is 4,509,725 shares of Class A Common Stock, or 8% of the issued and outstanding Class A Common Stock of the issuer.

Other individuals have the right to receive the dividends and the proceeds of sale from certain of the shares for which the undersigned have shared voting and dispositional control.
